Notice concerning the Acquisition of Surface Lease Rights of Land for Large Scale Solar Energy Power Generation by a Subsidiary of the Company

This is to give notice that in connection with the acquisition of an operating site for large scale solar energy power plant operations ("Large Scale Solar Energy Power Generation Facility Operations") of a subsidiary of the Company, the board of directors of the Company convened on August 29, 2013, has approved as described below a surface lease agreement to be concluded between the land owner and a subsidiary of the Company.

1. Outline

In order to further expand the Group's endeavors in Large Scale Solar Energy Power Generation Facility Operations, a surface lease agreement was recently concluded between Tango Textile Industrial Guild, the owner of the site concerned, and a subsidiary of the Company.

The subject site will be the location of solar energy power generation facilities with a total capacity of approximately 4,000 kW scheduled for construction. The construction of the solar energy power generation facility will be carried out with support from the City of Kyotango.

The Group will promote the strengths of the region by advancing the development of the large scale solar energy power generation facility in a close local context and will do its utmost to contribute to the region and its community through local job creation and other efforts.
