Tamagawa Holdings Announces Progress in the Business Alliance with ISE Power Co., Ltd.

As previously announced in the press release dated June 2, 2014, entitled "Notice concerning the Conclusion of a Business Alliance Agreement with ISE Power Co., Ltd.," dated May 30, 2014, Tamagawa Holdings and ISE Power Co., Ltd. ("ISE Power") concluded a business alliance agreement concerning solar energy power plant operations at ISE Power ("Business Alliance Agreement"). Tamagawa Holdings announces today progress in the said business alliance with ISE Power, with details as follows.

1. Background of the business alliance to date

During consultations between Tamagawa Holdings and ISE Power, based on the Business Alliance Agreement, concerning the further development of the solar energy power plant operations of ISE Power, in order to develop also the solar energy power plant operations of Tamagawa Holdings Group, on December 26, 2014, three consolidated subsidiaries of Tamagawa Holdings acquired the rights as power plant operators at Misawa city, Aomori prefecture, owned by ISE Power ("Power Sales Rights"), with a view to build and operate solar energy power plant facilities ("Power Plant Business").

The site required for the Power Plant Business was acquired by Tamagawa Holdings already on December 16, 2014. Notably, the acquisition price of the Power Sales Rights and the said plant site are subject to non-disclosure pursuant to oral non-disclosure agreement with the other party. The site, which was previously in use by the Ise Foods Group as a site for chicken farm operations, is currently idle. The site is flatland, with little snowfall due to its location on the Pacific side ensuring sufficient sunlight necessary for power generation, rendering it suitable for the Power Plant Business.

Note: The numbers associated with site surface area, power generation capacity, power sales revenue, and estimated power output in the first fiscal year reflect the combined totals of the four solar energy power plants operated by the four operating companies.

4. Future plans and outlook

Tamagawa Holdings is aiming for an early start of the Power Plant Business, with expectations to commence power sales by March 2016 (The timing of a power sales agreement with Tohoku Electric Power Co., Inc. has yet to be determined.).

Notably, while effects from the above-mentioned progress in the business alliance on the consolidated business results for the current fiscal year are expected to be negligible, any effects on results will be disclosed in a timely manner.
