We received from the current accounting auditor the offer saying they would like to refrain from renewal of the contract due to perspective of increasing audit manhours along with change in our management environment. Taking this opportunity, after we also considered increase, etc. of audit compensation according to the increasing audit manhours and reviewed again the accounting auditor, we newly select Avantia as the accounting auditor due to the reason of above 3.
